### 6. Cameroon

1. Documents should first be certified by the issuing authority (City council, School, Court Registrar, etc.), then secondly by the Cameroonian Ministry of External Relations
2. Legalisation by the Belgian Embassy

### 10. Ethiopia

Ethiopian documents to be used in Belgium need to be legalised by:

1. Legalisation by the Ethiopian Ministry of Foreign Affairs
2. Legalisation by the Belgian Embassy in Addis Ababa. Note: the Belgian Embassy does not legalise student copy of the transcript of record; only the original transcript of record can be legalised.

### **12. Ghana**

Before they can be legalized by the Belgian Consulate in Accra, Ghanaian documents must first be legalized by various entities.

Step 1: Legalization by a Notary Public

Step 2: Legalization by the Judicial service

Step 3: Legalisation by the Legal and Consular Bureau of the Ghanaian Ministry of Foreign Affairs and Regional Integration

Step 4: Legalisation by the Belgian Consulate in Accra
