#### Academic Year 2021-2022

The Flemish Inter-University Council (VLIR-UOS) awards scholarships to students from 31 countries in Africa, Asia and Latin America to follow a Master's program at a Flemish university or university college in Belgium. The scholarship covers all expenses related to the studies. For detailed information and eligibility requirements, please check the <u>VLIR-UOS website</u>. Prior to completing this application form, please also consult the admission requirements of the Master programme. Only candidates who meet all academic and scholarship admissions requirements should apply.

#### Scholarship Application Procedure

- <u>This application form is only for the VLIR-UOS scholarship.</u> You need to submit this form via the online application system, Mobility Online <u>together</u> with all other required documents as stated on the MEPI website (<u>www.uantwerp.be/master-epidemiology</u>) by <u>28 February 2021</u> at the latest.
- The Academic Selection Committee pre-selects 24 candidates who fit all scholarship and selection criteria, and who demonstrate the highest academic preparedness/potential necessary to succeed in the Master's program.
- Applicants will be informed of the result of the deliberation via email.
- In total 12 applicants will be nominated for the scholarship (A list), and 12 will be nominated for the waiting list. (B-list). This will then be submitted to VLIR-UOS by 30 April 2021 for further screening and approval. Applicants who are awarded the scholarship funding, as well as selected for the wait list\_will be contacted by VLIR-UOS by 15 May 2021 at the latest.
