The prevention system in Poland

- The Polish state implements its social policy through national programs
- The assumptions of which most often result from declarations and other documents of the United Nations initialed by Poland
- They also result from the documents and strategies of the European Union, which, as a member country, we are obliged to implement
- These programs take into account both the assumptions and priorities of international institutions, as well as the diagnosed problems and needs of the country.

Legal regulations

- The scope of tasks in the area of prevention and health promotion, implementers and sources of financing are indicated in several acts, including: in the Act on Public Health, the Act on Upbringing in Sobriety and Counteracting Alcoholism, the Act on Counteracting Drug Addiction and the Act on Health Protection against the Consequences of Using Tobacco and Tobacco Products.
- They determine the policy towards individual psychoactive substances at the national, regional and local levels, and the tasks indicated therein are taken into account in national prevention programs, the widest of which is the National Health Program.

National level – national prevention programs

Implementation

- Government administration
- Nationwide institutions: the State Agency for Solving Alcohol-related Problems (PARPA), the National Bureau for Counteracting Drug Addiction (KBPN), the Education Development Center (ORE), National AIDS Center, Institute of Psychiatry and Neurology (IPIN), Chief Sanitary Inspectorate (GIS) and others

Financial resources

- The budget structures of ministries indicated in individual acts as entities responsible for the implementation of state social policy

Regional level

- The priorities and activities included in the national programs are included in the voivodeship programs in accordance with the tasks assigned to local government administration at individual levels.
- The types of preventive activities carried out in the voivodeship are specified in the provincial programs: counteracting drug addiction and preventing and solving alcohol problems.

Local level

- Prevention activities at the local level are implemented through municipal programs for preventing and solving alcohol problems and drug addiction prevention programs.
- The source of financing for activities is the commune's own budget and additional funds obtained from fees for the use of permits for retail alcohol sales
- Additionally, communes can apply for funds from other sources: from central offices, marshal's offices, voivodeship offices, poviat offices, funds from EU projects or in the form of donations from private individuals or entrepreneurs.

Local level (2)

At the local level, non-governmental organizations (foundations, associations), specialized care and educational facilities (social therapeutic centers), addiction prevention and therapy clinics, church organizations, self-help groups, and families of addicts are authorized to carry out tasks in the field of addiction prevention in Poland.

- Preventing risky behavior and providing help to students at risk of addiction are also part of the tasks of the education system, in particular the tasks of schools and psychological and pedagogical counseling centers.
- Since 2002, a statutory obligation has been imposed on schools to implement a school program for the prevention of children and youth problems, which in 2017 was combined with the school's educational program into one document: an educational and preventive program.

Ministry of Health and National Health Fund Programs:

1. Early detection of breast cancer - ultrasound mammography, biopsy
2. Cervical cancer prevention - cytology, colposcopy
3. Prevention of cardiovascular diseases (CHUK)
4. Chronic obstructive pulmonary disease - prevention of tobacco-related diseases (including COPD)
5. Tuberculosis prevention
6. Prenatal tests
7. Hearing screening tests for newborns
8. Test for colon cancer

In the field of infectious diseases

- National Vaccination Program since 1960

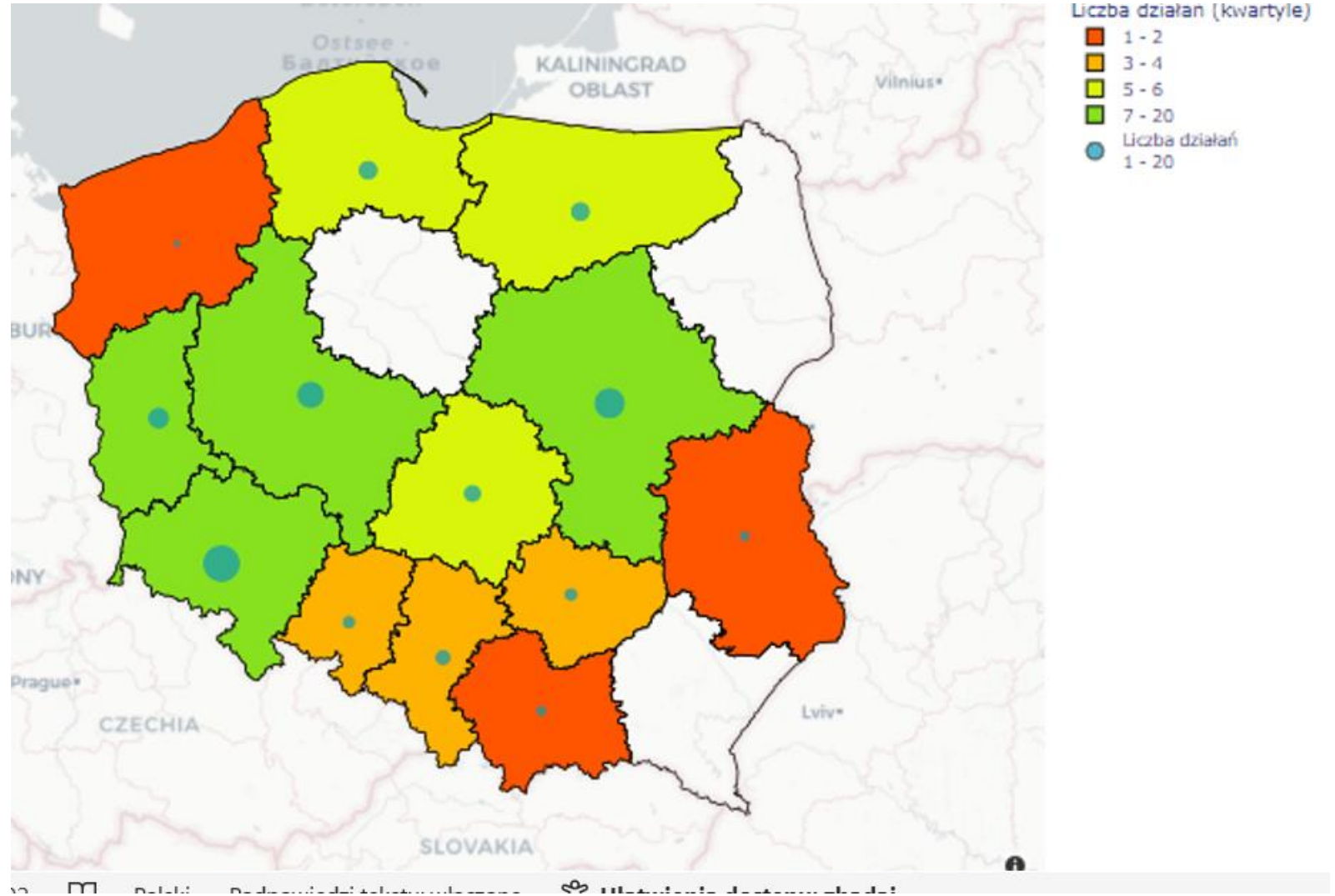
National HPV vaccination program

- Where - out patient facilities

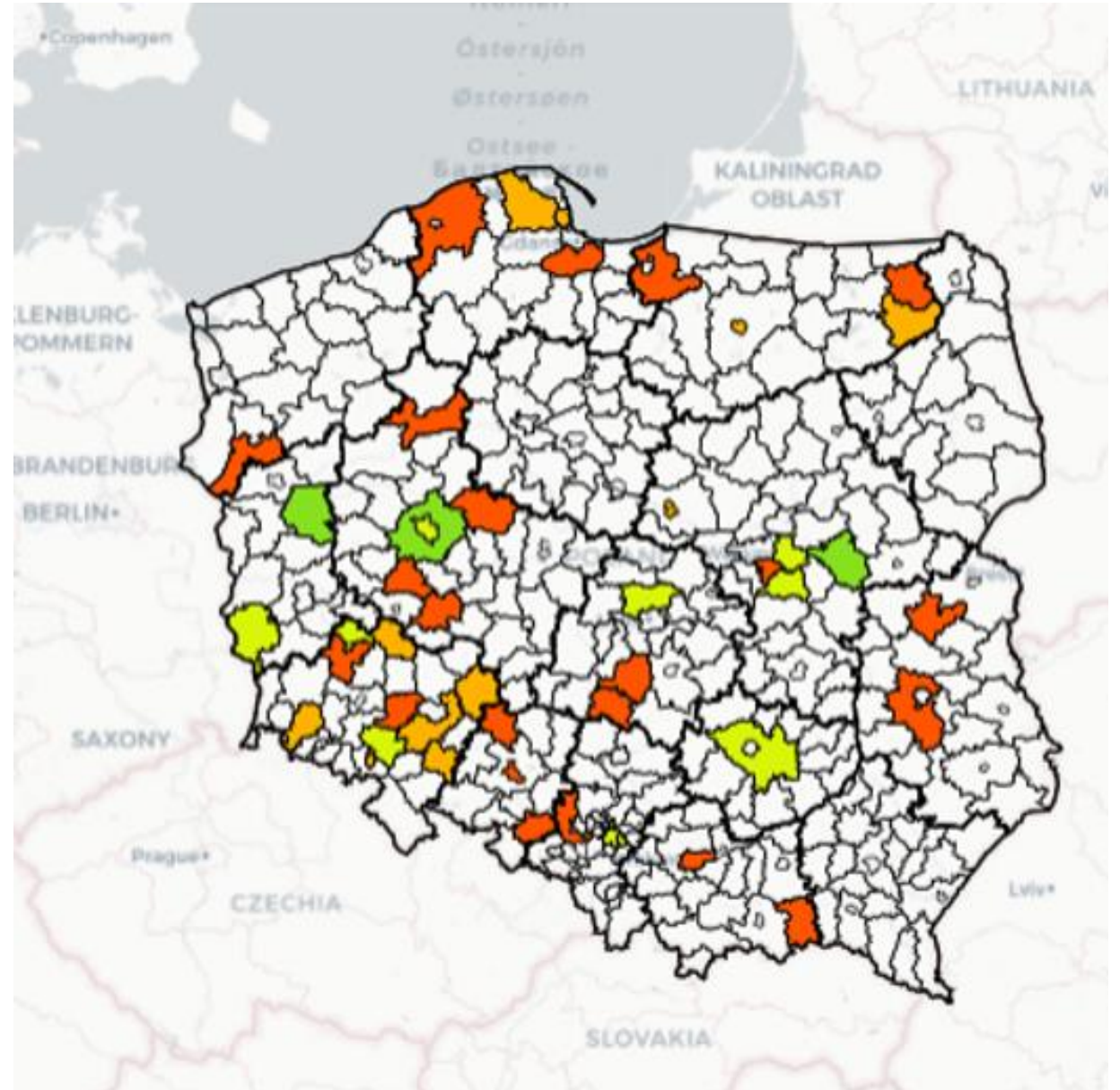
Local government programs, HPV vaccination

HPV program, number of activities completed, 2021

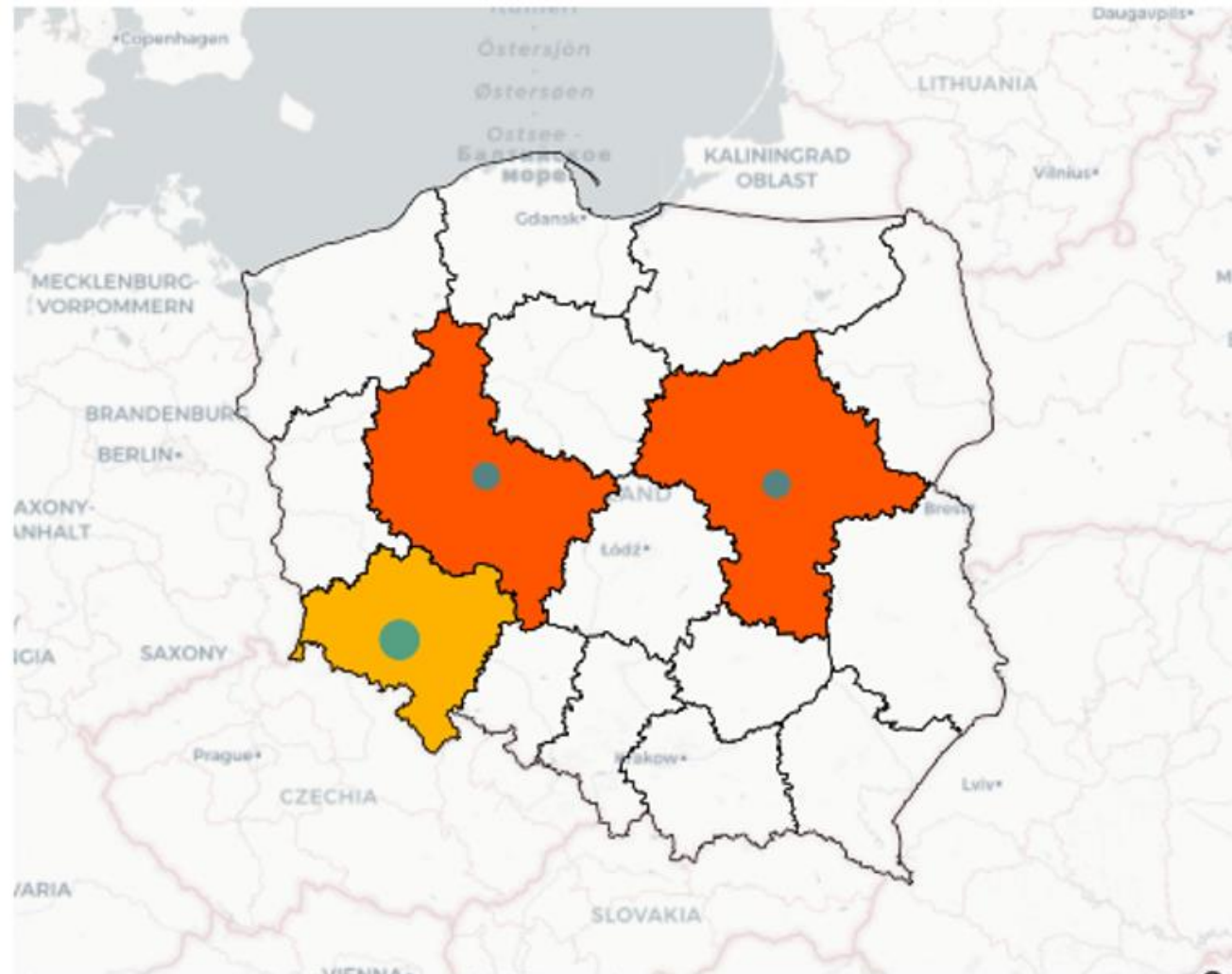

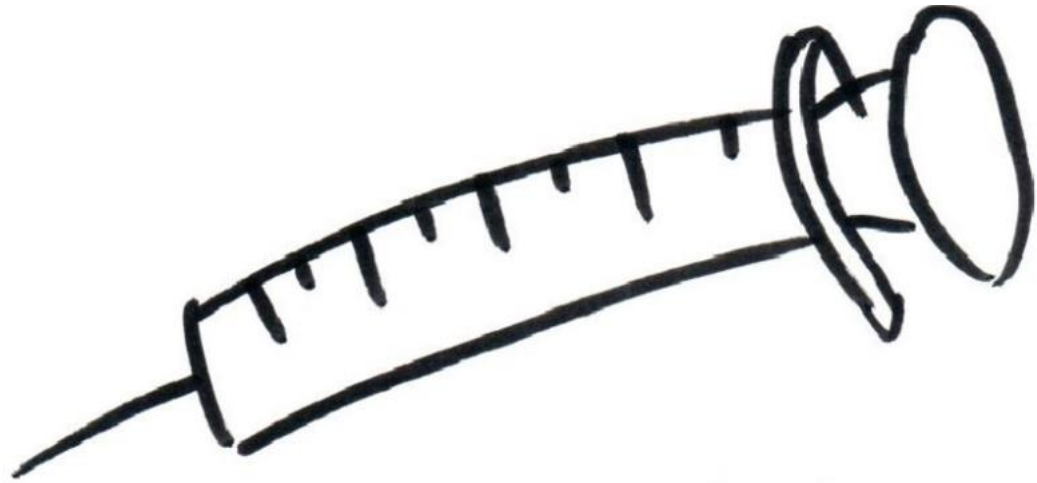
Summarize:
