<u>18th October, 2024 – Fourth edition of the joint BIRMM (VUB) – CESSMIR (UGent) – MIGLOBA (University of Antwerp) research day</u>

Words that matter: critical reflections on categorisation from migration and diversity research

The research day will focus on categorisation of migration and diversity. Keynote speakers in the morning and afternoon workshop will explore how policy, institutional and scientific categories related to migration and ethnicity are used in different contexts (e.g. census, political discourses, legal and policy work) and how these categories affect the social world and the way people think of migrants and ethnic minorities. Migration and Health Seminar - Bridging the gap: Health care in a super-diverse society

This 5th edition focuses on the topic Bridging the gap: Health care in a super-diverse society. Belgium is increasingly defined as a super-diverse society given the multiplicity of ethnic, cultural, religious and linguistic groups that inhabit the country. This Migration and Health seminar will highlight how barriers along the entire care continuum (health promotion, access to and retention in care) work both ways and can be overcome. The seminar will explore challenges from provider and patient perspectives, identify the gaps and showcase scientific projects and local initiatives with migrant, refugee and more generally culturally/religious/linguistic diverse populations to develop a more accessible and equal primary care system for all.

This seminar will address these questions through different presentations from experts from researchers and civil society members, and by engaging the audience in interactive question & answer sessions.

<u>Call for Abstracts – The governance of anti-discrimination: Insights into institutions, policies and networks – NIG Conference 6-7 February 2025, Ghent</u>

Anti-discrimination has re-emerged into the heart of governance at various levels, including the local level, the national level as well as the European level. Moreover, we see a clear connection between anti-discrimination governance and the rebuilding of trust in (government, political) institutions. In this panel, the primary focus will therefore be on institutions, policies, and actor networks in the field of anti-discrimination governance.

The organisers Prof. dr. Peter Scholten (chair), prof. dr. Annie Hondeghem (chair), and dr. Elien Diels (chair, corresponding reviewer) welcome papers that focus on the role of specific institutions, policies, or networks in the governance of anti-discrimination.

Important is that papers have a primary focus on the governance of anti-discrimination, so that the panel contributes to making meaningful connections between the theme of anti-discrimination and the broader literatures from public administration and political science. They especially welcome papers based on recent empirical research in the Low Countries, or based on comparative data in a European context.

<u>Call for Abstracts – Navigating the politics of (dis)integration: Refugee families' pathways to inclusion Conference – 23-24 April 2025, Brussels</u>

Keynotes by prof. Adrian Favell (University College Cork) and prof. Halleh Ghorashi (Free University Amsterdam)

This two-day conference will examine how the contentious 'politics of (dis)integration' shapes the social in/exclusion of different groups of migrants and their families, and how different actors navigate this complex, contradictory field of policies. We are particularly - but not exclusively - interested in contributions that zoom in on the specific sub-group of refugees (and their families), or that compare policies towards different groups of refugees (e.g. International Protection vs Temporary Protection Directive) and towards other groups of immigrants (e.g. family reunification, labour migration,...).

This is the final conference of REFUFAM, an interdisciplinary consortium examining the impact of Belgian migration-related policies on the social inclusion of refugees and their family members. www.refufam.be
