## **Call for Ideas: Approaches to Refugee Research**

The In Loco Consortium invites submissions for a participatory, refugee-led research initiative. This call welcomes ideas on research questions, interview frameworks, methodologies, and more. Selected contributions will be integrated into the research, with contributors collaborating with refugee researchers (RRs) and partners to refine questions, analyse findings, and co-create outputs like academic texts and reports.

Participation open to: individuals with a background in research or academia, as well as professionals working in the human rights and humanitarian fields.

Launched in October 2024, In Loco is a 3-year project funded by AMIF (Asylum, Migration, and Integration Fund). It is led by <u>Second Tree</u>.

The In Loco project aims to reshape refugee integration practices across 11 European countries, involving 40 refugee researchers and addressing key areas such as Housing, Healthcare, Education, Employment, and Social Relationships.

## New project: IMPULS. Urbanisation beyond gravitation. An interdisciplinary approach to ruralurban relations

An interdisciplinary team led by <u>Prof. Greet De</u> <u>Block</u>, co-director of the USI institute, will work on a new project aiming to elaborate theoretical and empirical models to understand the relationship between urbanisation, mobility and migration in the Belgian case. <u>Prof. Hilde Greefs</u>, <u>Prof. Joris Beckers</u>, <u>Prof. Stijn</u> <u>Oosterlink</u> and <u>Prof. Milena Belloni</u> will act as copromotors. Stijn and Milena will lead one work package focusing on how feelings of home and place attachment influence decisions to commute or migrate.

#### LATEST INITIATIVES BY OUR MEMBERS

#### PhD thesis defence by <u>Jasper Segerink</u>, "The lodging house and the city" – 14 February 2025

This dissertation studies the lodging house sector and its relation to changes in migration and urbanisation in Antwerp during the late nineteenth century (ca. 1850-1914). Although omnipresent in the historical cityscape, the lodging house features only scarcely in the works of historians. This dissertation aims to fill in this gap. It argues that the lodging house functioned as a crucial link between two of the period's most impactful transitions: the urban transition and the mobility transition. The processes and social mechanisms that connected these two together, have often remained implicit. In this dissertation, the lodging house is treated both as an expression of these transition – and thus a peculiar historical phenomenon meriting an understanding of its own internal mechanisms – and a lens on them, a key site to investigate how such transformations reverberated in the lives of ordinary people. With this goal in mind, this thesis adopts an approach that is fundamentally spatial and relational across scales. This method is applied through novel digital tools like GIS-mapping and building biographies, to a broad variety of sources ranging from police documents, legislative texts, population and lodging registers, newspapers, and historical novels and imagery.
