

Department members have given a series of **press interviews** during the latest months. Full details, and related textual, audio and video material is available through the Department's media page.

On 26 November 2013, dr. Jan Francke (KennisInstituut voor Mobiliteitsbeleid) gave a **guest lecture** on Dutch freight transport model applications.

On 18 and 20 December 2013, students Maritieme Wetenschappen and Zee- en Vervoerrecht of the Department as well as the Masters programs of the Faculty of Applied Economics pay visits to the Port of Antwerp and a number of its terminals. The **excursions** are hosted by the Antwerp Port Authority.

On 11 December 2013, Jeroen Pruyn successfully defended his **PhD** on 'Shipping and shipbuilding scenario evaluations through integration of maritime and macroeconomic models' at Delft University of Technology. The PhD was supervised by Ubald Nienhuis (TUDelft), Hilde Meersman and Eddy Van de Voorde.

The Department launched new **forecasts on freight transport in Belgium**. They are based on forecasts of the economic evolution by the International Monetary Fund and the Belgian Federal Planning Office. Twice per year, the Department provides an updated impact analysis forecast for Belgian freight transport. The forecasts and corresponding market analysis and interpretation can be found on this link.









On 5-6 September, 2013, Raimonds Aronietis and Christa Sys participated at the **7th RETROFIT project General Assembly (GA7) meeting** in Rotterdam (The Netherlands). EU FP7 research project RETROFIT, aims at combining available and newly developed technologies to fit existing ship configurations to improve energy efficiency and cleanness while at least maintaining but preferably improving the ships' economic performance. The GA7 was held at the foundation of the 'Centre for Maritime Technology and Innovation' (CMTI), the coordinator of the project.

The RETROFIT project has reached a development level where results can be presented to stakeholders from industry and end users. Therefore, on Thursday 7 November 2013, the Industry Interest group came together to discuss the project results.

On the same day, the midterm conference 'Green technologies for existing ships' was jointly hosted by the joint RETROFIT and GRIP projects at the Europort 2013 fair in Rotterdam. Green technologies, voyage simulation and energy consumption, retrofit process, and regulatory framework developments were the main topics discussed. Conference presentations can be found online.

On 6 December 2013, the Department hosted its **10<sup>th</sup> Air Transport Colloquium**, in co-operation with TransportNET. This year's presentations and discussions focused on the topic of "Innovations in the Sky - The Need for Changes in Passenger and Cargo Transport".

As in the previous years, the colloquium hosted interesting presentations by members from academia, policy and business, and brought together academic and business participants. Topics that were dealt with during the day include:

- The influences of competition and regulation on airport innovation
- The impact of the crisis on innovation





- The convergence of business models
- Low-cost airlines and cargo
- Cargo innovation at airports
- Mergers and acquisitions as innovation

The day concluded with a panel discussion with important market players and involving all conference participants. Pictures of the event can be found online.

On 6 and 7 November 2013, in the frame of the EU-funded COST Action 'P3T3 - PPP's in transport-trends and theory' (TU 1001), the Department of Transport and Regional Economics, the Research Unit on Public Administration & Management (Department of Political Sciences) and the Law Faculty of the University of Antwerp jointly hosted a two-day international conference on Public-Private Partnerships under the title 'Global challenges in PPP: cross-sectoral and cross-disciplinary solutions?'.

This conference was not just an academic conference on PPP, but had a number of specific features:

- High-profile key note speakers from the PPP academic community and high level policy community;
- Finished research and as well 'research in process' was presented and discussed;
- Confrontation of PPP research with insights and needs of practitioners and policy makers
- Focus on intersectorality: the conference enhanced the mutual learning between different sectoral fields where PPP's can be applied, so as to derive cross-sectoral conclusions;
- Focus on interdisciplinarity, i.e. all disciplines were treated (engineering, economics & accounting, legal, public management, political science...) and confronted their insights.
