## **Research Projects**

Jonas Wood studies family and labour market dynamics in Belgium and Europe. Particular attention is paid to varying patterns and inequalities across the life course by population subgroups such as socio-economic groups, gender dynamics, or different migration backgrounds. In addition, context-contingencies such as effects of economic conditions, institutional setting and normative setups are assessed. In order to disentangle varying outcomes across the life course by population subgroups and meso- or macro-level contexts, his research relies on longitudinal econometric or mixed method research designs.

#### **The Development of a Register-Based Socio-Demographic Panel to Study Work-Family Behaviour.**

As a result of the limitations of available data sources in the study of work-family behaviour, this project aims to enhance our knowledge by developing a Socio-demographic panel based on data from the Crossroads Bank for Social Security and the National Register. This data source allows a (i) longitudinal (ii) couple-level assessment of (iii) uptake and effects of work-family policies (formal childcare, parental leave, service vouchers) (iv) for detailed population subgroups. In addition, (v) close cooperation with our partner institutes in other North-western European countries with access to detailed register data will allow to compare work-family dynamics between countries.

This project uses a newly developed data infrastructure that links longitudinal register data from integration offices, employment offices and social security organisations to reconstruct and analyse labour market trajectories of both the resident population with a migration background (second and later generation migrants) and new migrants entering the country in the period 2005-2016 (first generation migrants), including asylum seekers.

This project aims to address the interplay between socio-economic developments and family formation by analysing rich register and register-like data. At the individual level, the main areas of focus will be on the trends by SES among females, males, or couples; and the effects of selective internal and international migration on fertility in high and less developed areas. At the contextual level, the main emphasis will be on fertility trends by level of economic development, costs of living, and opportunities to reconcile family and career goals. As part of the project, we have set up a European network of researchers called Register-Based Fertility Research Network. It brings together scientists who are collaborating to exploit individual-level and subnational variance in register and register-like data in order to improve our understanding of the recent shifts in the fertility-development nexus.

# Teaching Activity

**Social demography:** 2016-2017 (University of Antwerp, BA Sociology):

This course deals with the key concepts, trends, data and methods, and policy-implications in the three major demographic fields – family formation, migration, aging and mortality – as well as discussing the interrelatedness with other fields such as economics, sociology, social psychology. **BA Research Seminar:** 2017-2021 (University of Antwerp, BA Sociology): ‘Leeronderzoek’ is a practical course in which students carry out a sociological research. The full research cycle, from theory construction to reporting, is treated. In the 2017-2018, 2018-2019, and 2019-2020 Research Seminar, the output produced by students under supervision of Jonas Wood was of sufficient quality to be published in an academic journal, attract wide media attention and/or provide input to policy makers.

Research Seminar 2019-2020: A qualitative inquiry of how policy initiatives can successfully ‘burst the bubble’, meaning that international students would interact more with local students in Antwerp, Powered by GATE15.

**Population, family and the life course (state-of-the-art):** 2018-2021 (University of Antwerp, MA Sociology, MA Social Work). This course provides a state-of-the-art overview of theoretical and methodological frameworks used in the study of life courses, fertility, union formation, union dissolution, migration and population policies.

**MA Research Seminar – Population Projections and Simulations:** 2019-2021 (University of Antwerp, MA Sociology, MA Social Work). This MA research seminar covers the theory behind projections and simulations, but also assists students in their own policy-relevant population projection and related policy recommendations.

**Teaching Assistant Event history analysis:** since 2015 (KULeuven, Quantitative Analysis for the Social Sciences (QASS)): Within the advanced Master’s programme in statistics, Prof. Karel Neels teaches the module on event history analysis. My role as a teaching assistant includes the development of exercises in R, the organization of hands-on PC lab sessions, and contributing to the development of the QASS programme through participation in evaluation sessions.

**Antwerp Summer University - Europe: Diversity and Migration Summer School:** Europe's demography in terms of ethno-cultural composition is rapidly diversifying in an unprecedented way. The majority group in urban areas is morphing into a minority amidst other minorities. This is caused by the outcome of labour migration in the past, but equally so by continuous migration in the present and the recent inflow of large numbers of refugees. These topics have become a priority issue for policymakers at the national and EU-level. Leading (European) politicians such as Germany's Chancellor Angela Merkel have claimed multiculturalism has failed as a policy strategy, and new ways of addressing diversity need to be found. At the same time demographers are pointing out Europe's population will be shrinking if the rate of migration does not increase in the coming decades. There is a great concern from different ideological perspectives on how to deal adequately with superdiversity as it affects all realms of society and as continuing inequalities seem difficult to transform. The third edition of the Summer School ‘Europe: Diversity and Migration’ addresses these issues from an interdisciplinary perspective and in doing so, provides participants with insights, practices and skills to understand the current transformation of Europe ([link](#)).


